the defendant to be away from her house for that period of a time The neighbor looked into the defendant's window at 1112 Peachtree Street, and he saw the defendant's dog inside of its crate There were flies on the windows, and the dog was obviously deceased The responding officers could not locate the defendant, therefore, I was notified because they were concerned with the defendant's wellbeing Foul play was suspected because it was uncharacteristic of the defendant to be away from her residence, additionally, the neighbor explained that the defendant spent over \$1000 for her dog The defendant also spent a lot of time playing and walking with her dog

After five hours of searching for the defendant, she was located at 3815 Parapet Drive, which is five and six tenths miles from 1112 Peachtree Street The defendant was placed into custody for cruelty to an animal and transported to Cocoa Police Department In a post Miranda interview, the defendant advised that the last time she checked on her dog was January 18, 2008, and the dog was alive The defendant moved in with a friend because her water was turned off, therefore, she was unable to take her dog because her friend does not like dogs The defendant explained that she has left her dog unattended for one week before, and the dog was okay I expressed to the defendant that this could have been avoided, and if a dog is left alone for two months, it is apparent what will happen The defendant responded, "I know " The defendant showed little remorse for what happened

Animal control responded to collect the remains of the dog Animal control and I photographed the scene, and a CD-R containing photographs was placed into evidence A photograph of the deceased dog was attached to this affidavit Pursuant to F S S 938 27 and 775 089, the investigative cost incurred by this agency is \$617 90
